Parents or legal guardians are responsible for the following:

- Participants must check in at the Courtesy Desk each time when entering the facility.
 - Adult must be present at check-in and maintain presence in the building.
 - Before each lesson the participant is required to sign in at the Courtesy desk to have their lesson redeemed.
 - Participant must have lessons on account before a service is provided.
- Parent must provide child with proper swim attire.
- Parents **cannot** leave any children unattended on the pool deck. A responsible adult must be present on deck during child's program. Children on deck who are disruptive may be asked to attend the KidCenter during the lesson. There is to be one adult per one child on pool deck.
- No use of cell phones in the locker room.
- A parent may leave the pool deck for GLC programs/services/member tour, if permission is given by instructor and the adult is not responsible for any additional children on deck.
- As an **adult only** member facility, parents must supervise their children in the locker room. This includes :
 - Monitoring your child's behavior at all times
 - Being aware of other members/guests at all times
 - Consistent use of the designated 'family changing areas'
 - Children age 5 and older must use the gender appropriate locker room
- The **Quiet Zone**, the hallway in between the locker rooms, is **unavailable** unless necessary due to the age of the child.
 - The only appropriate time to use this area is if you are walking through with a child that is age 5 or over and of the opposite sex. **Please be sure to use your inside voices.**
- No cell phone conversations on the pool deck
- No strollers allowed on pool deck
 - We have a stroller parking section located outside of our KidCenter.

Release from Liability
